School Wish List – at the March Friends of Westlock Elementary meeting, it was decided that the next project that would be worked toward is another accessible swing for the grade 4-6 playground area. Currently the Parent Council is helping sell raffle tickets for the Rotary who is raising money for the new accessible park in town. We will hopefully continue to work with the Rotary to raise funds for the accessible swing set. We also discussed the funds we have set aside, and this project should be able to be completed in a timely manner. Tori talked with Mr. Tyreman and our idea of having the accessible swing on grass for accessibility reasons is not allowed in Pembina Hills, it is required to be on a surface of pea gravel or engineered wood fibre. Pembina Hills is able to cover the costs for the groundwork and fill during summer of 2026. On Wednesday, September 17th, a presentation was made to the Westlock 100 Women Who Care for the Accessible Swing Project for the grade 4-6 playground. The proposal was accepted, and the Friends of the Westlock Elementary are expected to receive \$9600 to build the new accessible swing. Tori will order the new swing and also the donor plaques for the previous swings and gazebo.

Further school item wish list for the 2025-2026 school year – Gazebo in Kindergarten-Grade 3 playground and new books for the library.
